Objectives

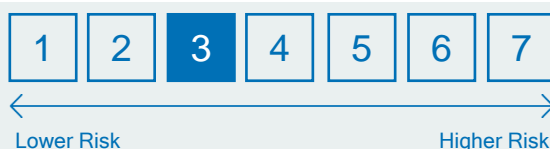
This portfolio's long-term objective is a cash return plus 3.5% to 4.5% per annum, gross of charges, with a target volatility of less than 15%. Mercer have chosen a portfolio of assets reflecting this objective, which is not guaranteed. Based on Mercer's market knowledge and investment expertise, this portfolio invests in a diversified mix of assets which may shift as Mercer's views change. Specialist active and passive managers are chosen, regularly monitored and where necessary replaced by Mercer. The allocations to managers and assets are regularly reviewed by Mercer and may change over time. The return for the investor will depend on the performance of the portfolio of assets in this fund. The risk profile of this fund is based on the seven year recommended holding period. Investments for longer terms are expected to lower the level of risk and shorter investment terms are expected to increase the level of risk.

Risk Indicator

Summary Risk Indicator (SRI)

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Zurich is not able to pay you. Zurich has classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Zurich to pay you. If Zurich is not able to pay you what is owed, you could lose your entire investment. The fund may use derivatives for investment purposes. Performance Scenarios
